YOU HAVE THIRTY (30) DAYS FROM THE STATEMENT DATE TO NOTIFY MYFLEETCENTER.COM OF ANY DISPUTED SERVICES. The customer agrees to pay any and all collection and legal fees incurred by Full Speed Automotive, regardless of whether legal action is taken.
